

Licence Agreement for the use of Data

between
Experian Ltd

of

Talbot House, Talbot Street, Nottingham NG80 1TH
(hereinafter referred to as "the Licensor")

and

The Experian QAS customer
(hereinafter referred to as "The Licensee")

1. Definitions

"Licensee" means the customer using this Data incorporated into a Experian QAS product and as named in the Experian QAS order confirmation form

"Experian QAS" means Experian QAS Ltd whose main trading address is George West House, 2-3 Clapham Common North Side, London SW4 0QL United Kingdom

Words and expressions defined in the Experian QAS Licence Terms and Conditions ("the Agreement") shall bear the same meaning herein and shall be incorporated by reference

2. Licence Grant

- 2.1 The Licensee is granted a personal non-exclusive licence ("the Licence") by the Licensor to use the Data only for the Licensee's own internal business use in conjunction with the Licensed Programs in accordance with the terms of the Agreement and this Licence.
- 2.2 Experian QAS is authorized by Licensor to manage this Licence on their behalf including monitoring your compliance with the terms and conditions of this Licence and all financial matters.
- 2.3 Experian QAS reserve all rights not expressly granted to Licensee.

3. Duration

- 3.1 This Licence commences on the date on which the Agreement (of which this Licence forms part) commences and continues until termination of the Agreement.

4. Intellectual Property Rights

- 4.1 All Intellectual Property Rights in the Data remain vested in the Licensor (or the Licensor's licensors). To the extent that any rights in such data and materials vest in the Licensee by operation of law, the Licensee, where the rights are of the nature of copyright and/or database rights hereby assigns such rights to the Licensor and, in the case of all other rights, agrees to assign the same to the Licensor. In any event, the Licensor will do such things as are necessary or desirable to vest all such rights in the Licensor. The Licensee will notify the Licensor promptly upon becoming aware of any unauthorised use of the Data
- 4.2 The Licensee shall not acquire any claim or title to any Intellectual Property Rights of the Licensor by virtue of the rights granted to it under this Agreement and the Licensee further agrees that they will not, at any time, do, or omit to do, anything which prejudices the Licensor's ownership of such Intellectual Property Rights
- 4.3 The Licensee shall not remove any proprietary notices of Licensor or Experian QAS placed on the Data or Licensed Programs or on reports generated through the use of the Data or Licensed Programs or on any media on which the same are supplied.
- 4.4 This Licence does not grant or imply any grant of a licence to use any trademark owned by Licensor.

4.5 The provisions of this clause shall continue to operate after the termination of this licence.

5. Licence Restrictions

5.1 The restrictions on use set out in Clause 8.9 of the United Kingdom (Standard Terms and Conditions for purchases and/or renewals post 1st April 2010) as found on the website at <http://support.qas.com/legal.htm> apply to the Data as if they were set out here in full.

5.2 The Licensee may not use the Data in connection with any immoral or unlawful purpose or for reasons which offend decency or taste. The Licensee will prevent use of the Data where reasonably required by the Licensor to do so to comply with the law or in the interests of taste, public policy or for other legal reasons.

5.3 For the avoidance of doubt this Agreement shall not entitle the End User to:-

5.3.1 provide any Data to any competitor of the Licensor and/or any organisation listed in Appendix 1;

5.3.2 to use the Data for direct marketing purposes where "direct marketing purposes" shall mean the use any of the Data in a single or multiple selections in connection with the offering for sale of the products and/or services of the Licensee by bulk post, SMS, electronic mail and/or telephone (including automated calling systems). For the avoidance of doubt, the foregoing shall not prohibit the Licensee from using the Data for the purposes of cleaning and/or verification of their marketing databases;

5.3.3 create using the Data any business directory, telephone directory or classified advertising directory in any media or format

6. Fees

Experian QAS will include in its initial and renewal licence fees invoiced to you, an amount for the fees due to Licensor for use of Data. Payment by Licensee to Experian QAS of their invoices discharges your liability to Licensor for the relevant initial and renewal licence fees.

7. Termination

If any agreement between Licensor and Experian QAS, or between Experian QAS or Experian QAS' agents and the Licensee (of which this Licence forms part) for the provision of the Data or services or products incorporating Data is terminated, this Licence will automatically be terminated.
